Mike Bozier Award

Criteria 2. What were the challenges and barriers that the organisation, team, or individual faced in implementing the initiative/strategy or contribution to our industry and how were they overcome? (300 words maximum)

Criteria 3. What positive impact or benefit does the initiative/strategy or contribution have on the industry and our workforce? (250 words maximum)

Marine Survey Practice Award

Criteria 1. Provide an overview of how the organisation demonstrates or promotes an ethical corporate culture and promotes the good standing of the industry through its business practices. (500 words maximum)

Criteria 2. How does the organisation foster and encourage the professional development of its surveyors and/or how does it contribute to the industry generally through mentoring and coaching others, providing advice and feedback on industry changes, or contributing to the development of standards and regulations or promotion of ethical behaviour? (500 words maximum)

Marine Surveyor Specialist Field Award

Criteria 1. Provide an overview of the specialist field and how the organisation demonstrates or promotes an ethical corporate culture and promotes the good standing of this sector of the industry through its business practices. (500 words maximum)

Criteria 2. What activities does the organisation implement to foster and encourage the professional development of the surveyors in this field and /or how does it contribute to the industry generally through training, mentoring, and coaching others, providing advice to other

surveyors or contributing to the development of standards and regulations or promotion of standards and regulations in this field? (500 words maximum)

Technology or Business Services Award

Criteria 1. Provide an overview of the product or service, why it was developed and how it has been implemented. Also provide an explanation of what barriers and challenges were faced and how they were overcome. (300 words maximum)

Criteria 2. How has the practical application of the technological solution, business service or product furthered or simplified the business practices of marine surveyors and/or how has the technological solution, business service or product resulted in a commercial, environmental and/or social benefit to the industry or positively contributed to the marine survey industry in any capacity and/or how the product or service actively supported the industry including identification of best practice methodologies? (500 words maximum)

Student of the Year Award

Criteria 1. Provide an overview of the qualification you are enrolled in, your employer (where applicable) as well as your reason for choosing the industry and training pathway. (200 words maximum)

Criteria 2. Explain the challenges you have faced in undertaking the training and gaining practical experience and how you overcame these. (300 words maximum)

Criteria 3. Provide an overview of how you have supported your training with other courses, or attendance at conferences, seminars, meetings, or other networking events. Also state where you intend to go from here and why. (200 words maximum)

President's Rising Star Award

Criteria 1. Why do you believe the nominee is a 'rising star'? Your explanation should provide detail/examples on how the nominee meets the criteria. The judges will look for examples of personal achievement by the nominee that include but are not limited to innovation, outstanding personal contribution, or result achieved, completed tasks with quality results, improvement in safety, productivity or profitability or their commitment to learning the profession. (1000 words maximum)

Criteria 2. Explain how the nominee has demonstrated leadership within their team or organisation and/or has the potential to be a future leader in the industry. (500 words maximum)
